# **KEYNOTE ADDRESS**

## **New York State Senator Robert Ortt**



Robert enlisted in NY Army National Guard in October 2001 in direct response to the attacks on September 11th. He is a veteran of Operation Enduring Freedom in Afghanistan, where he served from March 2008 until December of the same year. His mission was to serve as a combat mentor/advisor to the Afghan National Police in Kandahar City, the second largest city in Afghanistan. As the Executive Officer/Unit Movement Officer for an infantry company, he was responsible to ensure that all the logistical needs of the company were met to facilitate operational readiness, coordinate and run all company meetings, and act as the commander in his absence. He successfully moved \$10 million worth of equipment to Afghanistan and back to the United States.

He is the recipient of the Bronze Star, the Army Commendation Medal, the Afghan Campaign Medal and the Combat Infantryman's Badge in recognition of his service.
