MEMBERSHIP PROGRAM OVERVIEW

Headway of WNY, Inc. is a membership organization that was originally founded in 1985 by survivors of brain injury and their families who advocated for more local services as alternatives to institutional care. Membership was one of the main vehicles that created the foundation of the agency.

By 1995, this original group of members and supporters had become active in advocating for governmental policy changes and as a result, Headway was one of the agencies that was pivotal in starting the Traumatic Brain Injury (TBI) Medicaid Waiver program, followed by the Nursing Home Transition and Diversion Waiver in 2009. These Medicaid Waiver programs are funded by the New York State Department of Health.

Although Headway of WNY, Inc. is the Regional Resource Development Center, established to administer the two above noted Waiver programs, it is also a support and advocacy agency for persons with brain injury and other cognitive conditions, including seniors. Memberships, annual donations and special event fundraising, provide the basis of activity for the side of Headway that is not supported under New York State Health Department Waiver programs.

In 2012, Headway became affiliated with People Inc. and over the years, the Membership program has evolved, raising a small percentage of the overall mix of fundraising initiatives that Headway utilizes on an annual basis (including special events and annual donations). Membership includes a variety of benefits and most importantly offers the community an opportunity to raise awareness for Headway's mission. Some members serve on Headway's Advisory Council, which meets on a quarterly basis and provides ideas, outside of the agency's perspective, and support on strategic planning. Members are a community of people who share common values and concerns about individuals and family members, support systems in Western New York, and education about TBI and other cognitive conditions. Members help sustain the mission and vision of the agency and are often active participants and/or volunteers at special events and fundraising activities.

Membership funds help provide outreach and support in a variety of ways, including, but not limited to: support groups, newsletters, mailings, e-newsletter and updates, website and social media updates, educational presentations, advocacy and assistance in identification of supports, as needed.


